Remote notarizations can be used in the following situations. However, notarizations that meet the requirements of this statute are limited in scope and application due to security concerns. With credit card transactions, the notary must meet stringent security requirements for remote notarization. The notary must work for a third party that provides remote notarization through secure telecommunication pathways or electronic devices. Second, when the notary public is physically located outside of the State of New York and the designated party is located in the State of New York, there is no electronic transmission of documents. The notary public must meet the requirements of the State of New York law, which may not be consistent with the New York State law on notarial acts. 1. Notaries in New York who are unable to meet the physical presence requirements may opt to have the electronic transmission of records registered with the Department of State. The notary must apply for permission to be able to electronically transmit documents to the Department of State as required by the New York State Notary law for remote notarization. To apply for permission, the notary must be in good standing with the New York State Notary Law. The application must include the notary public's name, the first and last name of the principal, the address of the principal, the business name of the principal, the email address of the principal, the telephone number of the principal, the names, addresses and telephone numbers of any intermediaries (e.g., the publisher, the notary public's agent, a third party that is licensed to represent the notary, the notary public's acquaintance, and others) who would be notified of a remote notarization, and a statement that the notary has reviewed the electronic transmission provisions of the New York State Notary Law to ensure that the electronic transmission of documents complies with those provisions.

Application Process To provide remote notarization in the State of New York, a notary must register with the New York Department of State, Office of the Commissioner of Financial Services. New York Remote Notary Law State law was amended to allow for remote notarization of documents in the State of New York. The law permits the use of security technologies such as video, voice, audio and secure messaging. For remote notarization, the law requires that the notary public record the notarization and upload the notarization to the state of New York. For a video or audio notarization, the law requires that the notary public record the notarization and provide the recorded audio transmission to the state of New York.
